# **RESEARCH POLICY**

Rapid growth in scientific knowledge is an indication of quest for discovery and has an impact on economic and societal development. Research is the foundation of knowledge that brings new energy, promotes research publications, develops collaborations and becomes part of active community that shares the mission objectives. Taking these into considerations, Maharajas College implemented the following research Policy.

Maharaja's college creates an open platform to foster academic excellence and to pursue scholarly research activities and is committed to promote a research culture among faculty and students as basic long term research provides the foundation for future development of the Institution. The research policy of the college aims to develop and promote scientific temper and research aptitude of all learners; to realize the vision and mission of the college and to identify research areas of academic, practical and socially relevant significance thus contributing to national development. It also aims at ensuring that the research activities of the college conform to all applicable rules and regulations of the affiliating University and U. G. C. as well as to the established standards and norms relating to safe and ethical conduct of research. Our research policy provides a broad framework to the research activities with the following objectives:

### **Objectives**

- To create an enabling environment within the Maharaja's College in order to foster a
  research culture as well as provide required support through research framework and
  guidelines.
- To provide a proper coordination of all research activities of the college and aligning these to the vision and missions of the college and national development goals through Maharaja's College Research and Consultancy Cell.
- To identify and inform researchers about the appropriate research opportunities announced by different academic, research, industry or government organizations.
- To promote interdisciplinary research and establish modalities for preparing and undertaking joint research projects covering more than one knowledge domain as well as policies or involving external agencies/experts in such projects.

- To create an awareness about patents and Intellectual Property Rights and motivate them to apply for patents.
- To take initiative for granting study leave, sabbatical leave, duty leave, seed money, reduction in workload, etc. to deserving faculty members for advanced research.
- To identify and establish linkages including MOUs for long term relationships with national and international research organizations for widening the scope of research opportunities and funding options available to the teachers and students of the college.
- To promote collaborations with International and national academic institutions of higher learning and promote linkage with Industry.
- To encourage and facilitate the publication of the research works in reputed academic International / National journals and also to facilitate the presentation of the research work through academic events such as workshops/seminars/conferences.
- To create an ecosystem for innovations including Incubation Centre and other initiatives for creation and transfer of knowledge.
- To facilitate community oriented research initiatives and to transfer the research findings for the social and economic development of the community. To ensure the quality of all research activities of the college and to observe the highest standards of ethics and integrity in the conduct of their research, all researchers must follow the following Code of ethics.

#### **Code of Ethics for Research**

- All scholars pursuing research in the college are expected to maintain high standards
  of integrity, honesty and professionalism in respect of all the work undertaken by
  them.
- An ethics committee has been constituted and an Operating Procedures is adopted for monitoring research activities of the college.
- Since the college is affiliated to Mahatma Gandhi University, Kottayam, the college follows the regulations of the University and UGC regarding plagiarism and malpractice in research.
- Ph.D thesis submitted from the Institution is screened by Mahatma Gandhi University, for plagiarism before it is accepted. Regarding paper publications, each student can avail the facility in the university to check for plagiarism.
- Whenever a paper is to be published in peer reviewed journals, the journal will normally have a committee to check the originality in the content.

An ethics committee has been constituted and an operating procedure (OP) is adopted for monitoring research activities of the college. The objective of this OP is to contribute to the

effective functioning of the Committee by ensuring a qualitative and consistent ethical review mechanism for health and biomedical research involving human participants.

## **Operating Procedures for Research Ethics Committee**

## Objectives:

- To contribute the effective functioning of Maharaja's College Ethics Committee, a qualitative and consistent ethical review mechanism for health and biomedical research is put in place for all proposals dealt by this Committee.
- This Committee shall follow the Indian Council of Medical Research (ICMR) Ethical guidelines for biomedical research on human subjects.

## Role of Maharaja's College Ethics Committee:

- The mandate of the Maharaja's College Ethics Committee shall be to review all biological research/research projects involving human subjects to be conducted in the Maharaja's College research centre under Mahatma Gandhi University, irrespective of the funding agency.
- Maharaja's College Ethics Committee Shall review and approve all types of research proposals involving human participants with a view to safeguard the dignity, rights, safety and well -being of all actual and potential research participants.
- The goals of research, however important, should never be permitted to override the health and well- being of the research subjects.
- The Maharaja's College Ethics Committee shall take care that all the cardinal principles of research ethics viz. Autonomy, Beneficence, Non maleficence and Justice are taken care of in planning, conduct and reporting of the proposed research. For this purpose, it will look into the aspects of informed consent process, risk benefit ratio, distribution of burden and benefit and provisions for appropriate compensations wherever required.
- The Maharaja's College Ethics Committee shall review the proposals before start of the study as well as monitor the research throughout the study until and after completion of the study through appropriate well documented procedures like annual reports, final reports, site visits etc.
- The committee shall also examine compliance with all regulatory requirements, applicable guidelines and laws.

## Structure of the Maharaja's College Ethics Committee:

- The committee shall be multidisciplinary and multi-sectorial in composition.
- The number of persons in an ethical committee shall be kept fairly small.
- A minimum of five persons is required to compose Quorum for ethical committee.

The composition shall be as follows:-

- (1) Patron
- (2) Convener
- (3) Coordinator
- (4) Committee Members
- i. The Patron of the Committee shall be from outside the College.
- ii. The Co-ordinator shall be from any of the Science Departments of the college and shall conduct the business of the Committee.
- iii. The Maharaja's College Ethics Committee shall have as its members from other institutions or communities if required.
- iv. There shall be adequate representation of age, gender, community, etc. in the Committee to safeguard the interests and welfare of all sections of the community/society.
- v. Members shall be aware of local, social and cultural norms, as this is the most important social control mechanism. If required, subject experts could be invited to offer their views, for example for drug trials a pharmacologist, preferably a clinical pharmacologist, should be included.
- vi. Similarly, based on the requirement of research area, for example HIV, genetic disorders etc. specific patient groups may also be represented in the Committee.
- vii. All the members of the Maharaja's College Ethics Committee shall be appointed by the Principal, Maharaja's College Ernakulam, based on their competencies and integrity, and could be drawn from any public or private Institute from anywhere in the country.

- 1. The meeting approved the minutes of the previous governing council meeting.
- 2. The Controller of Examinations (CE) presented the results of I semester PG (2019 Admission, Regular). III semester UG Regular (2018 Admission). I semester PG (2018 Admission, Improvement/Supplementary). I semester PG (2016 Admission, Supplementary). III semester UG Improvement/Supplementary (2016 Admission). III semester UG Supplementary (2016 Admission) and III semester UG Supplementary (2015 Admission) Examinations and GC approved the results for publication.
- 3. The Principal presented a request from the II Semester MSc Mathematics students regarding granting moderation during valuation and challenge valuation procedures. The meeting discussed the issue and was of the opinion that the present regulations do not allow the governing council to grant moderation and it was noted that the pass board of the examination concerned has not recommended moderation as well. Any change in the mode of challenge valuation is to be decided by the Academic Council.
- 4. The meeting approved the request from the Controller of Examinations to utilize the accumulated balance under the CE Accounts for meeting the immediate fund requirements on the condition that the utilized amount shall be refunded when the fund from college office is transferred.
- 5. The Controller of Examination brought to the notice of the GC that the CE Office has received the copy of the order from MG University, in compliance with the GO, Govt of Kerala to increase the examination fees by 5%. The meeting directed the College Office and the CE Office to implement the above order from the next end semester examination onwards.
- 6. The meeting decided to constitute a committee to study and report on grace marks to be awarded to various categories of disabled persons. The members include: Dr. Suresh V.N. Controller of Examinations, Dr. K.V Jayamol, Vice-Principal and Dr Shajila Beevi, Member, Governing Council.
- 7. The Governing Council resolved to approve the submission of the Research Committee Coordinator to constitute a Research Ethics Committee. The Research Policy and the Consultancy Policy of the College were approved and handed over to the Academic Council.
- 8. Since the nominated member of the UGC to Governing Council stands vacant, the meeting decided to write a letter to the UGC to nominate a member to the Governing Council.

9. Other matters were deferred to the next meeting.
