The admissible grant under trescheme will be released to the College as per its eligibility, according to the norms as laid down the XII Plan Guidelines for Autonomous Colleges by the Deputy Secretary, UGC South-West Regional Office, Prasana Kumar Block Palace Road, Gandhi Nagar, Bangalore – 560 00 p.
