Feedback Analysis and Quality Improvement in Maharaja's College

Feedback from the stakeholders is an important component in the quality improvement strategy of Maharaja's College. The College values the feedback from students, teachers, parents and alumni, and takes into consideration while designing quality improvement measures including syllabus revision.

Students and teachers can submit as many feedbacks during the course of a year. However, for the sake of uniformity in analysis, feedback from teachers is taken during the final month of the academic year. Students are also encouraged to submit their feedback during this period. Parents may record their feedbacks twice in a year. Usually the feedbacks from parents are received during the class wise meetings in each semester. Each alumnus can send in their feedback once in a year. Though the feedbacks are being received throughout the year, the analysis is made once in a year.

The feedback is first analysed by the IQAC in the month of January- February. Thereafter the matter is placed before the Council with the observations and recommendations. The Council takes further decisions on the basis of the report and gives appropriate directions to the concerned.





Action Taken Report 2018-19

Based on the recommendations and instruction of the College Council for the previous year, IQAC increased the number of feedback criteria for different stakeholders during 2018-19 so that a more comprehensive feedback could be received. The numbers of feedback has also increased considerably.

The feedback from all the stakeholders was analysed and discussed in IQAC in February 2019. IQAC decided to bring the matter before the College Council of the College along with the findings and recommendations.

The College Council deliberated on the matter and pointed out that there is a need for taking steps to further increase the number of participants in the feedback. The Council suggested that the procedure should be made online so that the stakeholders can submit it more easily and flexibly. The Council further decided to incorporate the insights from the feedback while revising the UG syllabus this year.
