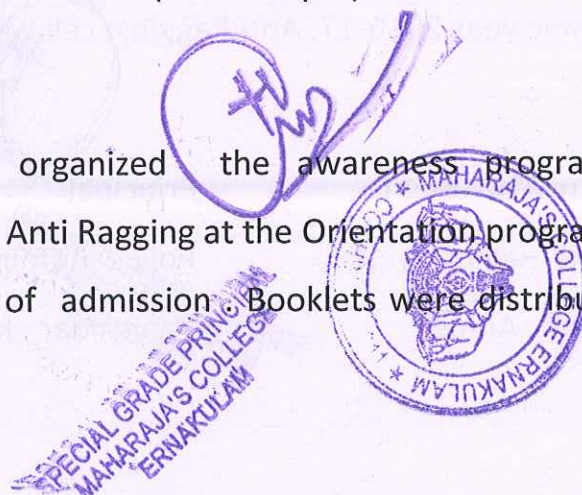

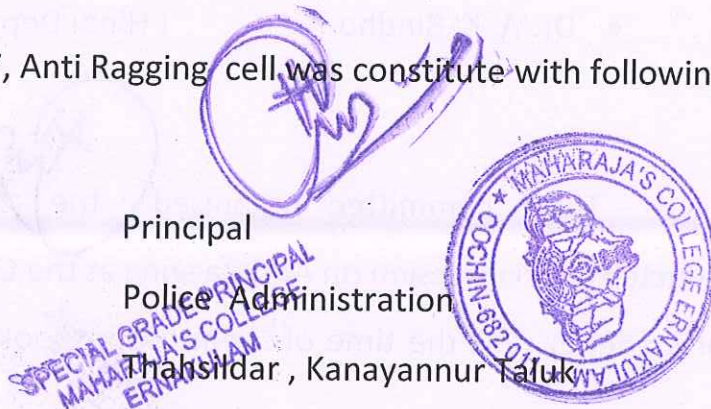
Decisions taken by the committee on ragging issue
